

Avalanche Cheese Company's Hand Bandaged Goat Cheddar is an award winning cheese which we highly recommend for any gathering of friends or family. code corner

2009 international residential code

We know that the 2009 International Codes have been in place for a while in some jurisdictions, but there are many significant changes to consider that affect what we do each day as Architects, Interior Designers, Builders and Home Owners. One small change (at least small in the amount of space it takes up on the page), is the Section M1503.4, *Range Hoods, Make Up Air Required*, in the International Residential Code. This is a small new addition to the code, with potentially significant financial ramifications, impacting most remodels or new construction projects where a new kitchen cook-top or range is provided. Since the kitchen is usually the first room remodeled,

you will probably come across this sooner or later in your projects.

The critical component of this section is that any kitchen hood that exhausts more than 400 CFM now requires that make-up air to be supplied to compensate for the exhausted air. Most of the high-end residential gas and electric ranges need or require an exhaust hood that exhausts air to the outside of the residence (i.e. not a re-circulating hood) and those hoods often exhaust, 600, 900, or even 1,200 CFM. This means an additional ventilating system will need to be installed to replace all of the air being removed by

the hood. First of all, this alone will be additional expense. Secondly, depending on available space in the home or condominium and available access to outside air, it may be difficult on a remodel to provide the replacement air.

It is necessary to mention however, that this new important requirement creates a safer living environment. Its primary purpose is to improve indoor air quality, but it will also make your home less drafty and improve the venting of your wood burning fireplace (if you have one).
